Make sure that staff and families know that they (staff) or their children (families) should not come to school, and that they should notify school officials (e.g., the designated COVID-19 point of contact [e.g., school nurse]) if they (staff) or their child (families) test positive for COVID-19 or have been exposed to someone with COVID-19 symptoms or a confirmed or suspected case. These critical communications should be accessible to individuals with disabilities and limited English ...

2. Suggested Lockdown with Intruder Procedures. The following procedures should be followed when the threat or intruder is inside of the school building: Building administrator orders and announces "lockdown with intruder." Be direct. DO NOT USE CODES. This announcement should be repeated several times.
